



**Radio Halesowen Town**  
**Copyright and Intellectual Property Rights.**  
**Station Policy Statement**

Copyright exists on all Radio Halesowen Town broadcasts, sound recordings, interviews and podcasts. Intellectual Property Rights apply to original content of all broadcasts, sound recordings, interviews and podcasts. In all instances, Radio Halesowen Town broadcasts, sound recordings, interviews and podcasts includes the audio content of any visual output, TVStreams, Mobile phone or Video Camera recordings.

The rights to Radio Halesowen Town broadcasts, sound recordings, interviews and podcasts are ceded to Halesowen Town FC. Ceded work may be re-broadcast, edited or otherwise used in accordance with usual custom and practice. In operational practice, the rights may be ceded to a third party at the discretion of the Halesowen Town FC's representative present during recording or production, including but not restricted to Black Country Radio

Recordings of Radio Halesowen Town broadcasts, sound recordings, interviews and podcasts taken simultaneously by a third party on any device, may be used for transcription to text immediately, provided that the wording is unaltered and the Intellectual Property Rights of Radio Halesowen Town are credited, where the first party is the originator (Radio Halesowen Town or its appointed agent) the second party is the subject where applicable (interviewee, studio guest, etc.) and the third party is any other person or persons present at the source of the Radio Halesowen Town broadcast, sound recording, interview or podcast.

The Intellectual Rights rest with the First Party.

Under Intellectual Property Rights, any recording taken simultaneously of a Radio Halesowen Town broadcast, sound recording, interview or podcast on a third party device, audio or visual, may not be broadcast until the original has been posted by Halesowen Town FC on its Official Website, or until 48 hours have elapsed from the date and time of the recording, whichever is earlier. Black Country Radio are specifically excluded from this clause. Any third party recording howsoever used must credit Radio Halesowen Town as owner of the intellectual property.

All sound recordings originated by Radio Halesowen Town that are posted on the Official Halesowen Town FC website, including Video Audio content, may be re-distributed by hyperlink. In such cases they should be credited to Halesowen Town FC and Radio Halesowen Town and should only be re-used in an unedited form..

Other Radio Halesowen Town broadcasts, sound recordings, interviews and podcasts posted elsewhere by Radio Halesowen Town, other than on the Official Halesowen Town FC website, including but not exclusively, Facebook & X, if downloaded or hyperlinked, should be credited to Halesowen Town FC and Radio Halesowen Town and should only be used in an un-edited form unless prior permission has been granted by a Halesowen Town FC Media representative or a Radio Halesowen Town Station Manager/Administrator.

The Radio Halesowen Town name and any associated logos or graphics are copyright. Permission to use any such graphics by a third party user, must be obtained from a Halesowen Town FC Media Representative. Intellectual Property in law covers

- original non-literary written work, such as software, web content and databases
- sound and music recordings
- film and television recordings
- broadcasts

### **Copyright law prevents:**

- copying the work
  - distributing copies of the work, whether free of charge or for sale
  - renting or lending copies of the work
  - performing, showing or playing the work in public
  - making an adaptation of the work
  - putting the work on the internet
- where 'the work' is any Radio Halesowen Town broadcast, sound recording, interview or podcasts
